Sub.: Request of the school for extension of general affiliation beyond 31.03. 2019

Sir/Madam,

This is with reference to your application bearing registration no. **EX-02152-1920** dated 25/06/2018 on the subject cited above.

In this connection, I am directed to inform you that keeping in view the academic interest of the students, extension of general affiliation has been extended upto 31.03.2020 provisionally and the school is allowed to register its bonafide students of class IX/X& XI/XII accordingly as per eligibility and norms of the Board.

However regularization of general affiliation from 01.04. 2019 for a period of 05 years will be subject to the outcome of the inspection report and specific compliance of deficiencies, if any, by the school.

Further, it is also informed that on scrutiny of the application of extension and documents submitted by school, the following deficiencies have been observed, which need to be complied by school before the periodical inspection of school and documentary evidences to this effect must be produced before the inspection committee at the time of inspection & duly attested copy of compliance be submitted along with inspection Committee report.

- 1. The school is required to re-constitute School Managing Committee as per Affiliation Bye-Laws, 2018.
- 03 PRT, 05 TGT and 01 PGT teachers are short to appoint more teachers and also to maintain section teacher ratio i.e. 1:1.5 teachers per section at each level. Hence, the school is required to submit a copy of revised staff statement with showing Name, Qualification, Designation, Date of Appointment, Date of Confirmation etc.
- The school is required to submit copies of renewed certificates of Fire Safety, Building Safety, Health-Sanitation and Safe Drinking Water (as per formats (appendix) given in Affiliation Bye-Laws of the Board) duly issued from concerned/competent authority i.e. Fire Department, PWD, Municipal'- Health Department etc. of the State Government.
- 4. The school is required to procure more books, i.e., 05 books per student.
- The school is required to submit a latest copy of EPF Challan in favour of school's name. A
 documentary proof regarding implementation and regular deduction of EPF is required to be
 submitted by the school along with latest Pay Bill and Bank Challan.
- 6. The school is having excess enrolment in some sections which is making the classes over crowded. As per Affiliation Bye-laws of the Board the optimum strength of a section should not exceed more than 40 students. Hence, the school is required to submit the clarification in this regard.
- 7. The school is required to renew the Reserve Fund as per strength of the school in the joint names of Principal of the school & member of Managing Trustee/ Member of the Society/ Trust running the school as per provisions of Affiliation Bye-Laws of the Board and copy of FDR may be furnished to the Board for record purpose.

The school has running 24 sections against 20 classrooms. Hence, school is required to submiclarification that how the school is accommodating and managing the same.
